On the basis of Article 27 of the Regulation with legal force on Institutions (Official paper of the Republic of BiH, no.: 6/92, 8/93 and 13/94), Article 29 of the Rules of the PI "Centre for Culture and Tourism" Cazin, Article 20. Rules of Procedure of the Management Board of the PI "Center for Culture and Tourism" Cazin, the Management Board of the PI "Centre for Culture and Tourism" Cazin, at its 12<sup>th</sup> regular session held on March 13, 2023. year, brings:

## **RULEBOOK ON HOUSE REGULATIONS FOR OLD TOWN OSTROŽAC**

March, 2023. Year

#### **Article 1**

This house regulation rulebook determines the rules of behaviour at the location of national monument „Stari grad Ostrožac“, Ostrožac bb (further stated as Stari grad- old town). This rulebook refers to the entire construction unit, which is consisted of medieval fort, fort from the Ottoman period, Lothar von Berks's castle and sculpture collection that is in natural surrounding of Old town- Stari grad.

#### **Article 2**

Articles of this rulebook are applied to all persons during their stay at the location of Stari grad- Old town.

#### **Article 3**

Maintenance of space and surveillance of Stari grad- Old town is being done by employees of public institution Center for culture and tourism Cazin (further stated as the Center).

#### **Article 4**

Employees of the Center have the obligation to keep the entire area and property at the location Stari grad- Old town and pay attention as an example of good hosts.

#### **Article 5**

Regular visiting hours for Old town- Stari grad is between 09:00 a.m.- 20:00 p.m.

#### **Article 6**

Working hours for employees of the Center is determined according to the Rulebook of the Center for culture and tourism Cazin for work regulations.

#### **Article 7**

It is forbidden to enter Stari grad- Old town without daily or annual entry ticket.

#### **Article 8**

It is forbidden to bring guns, alcohol or glass objects into the area of Stari grad- Old town.

#### **Article 9**

It is forbidden to climb the walls and statues inside Stari grad- Old town.

#### **Article 10**

It is forbidden to drop cigarette butts, to dispose garbage other into garbage bins.

#### **Article 11**

It is forbidden to light fire within the area of Old town- Stari grad.

#### **Article 12**

It is forbidden to bring dogs without a leash to the location of Old town- Stari grad.

#### **Article 13**

It is forbidden to write or draw on monuments and walls within Old town- Stari grad.

#### **Article 14**

It is forbidden to take photographs and video shots for commercial purposes without previous compliance of the Center.

#### **Article 15**

All visitors as well as employees of the Center must behave in accordance to the Public order law.

#### **Article 16**

Entry for all vehicle into Old town- Stari grad is forbidden, unless previously agreed with the Center.

#### **Article 17**

Visitors and employees at Old town- Stari grad are obligated to follow safety restrictions within the area of the location.

#### **Article 18**

It is forbidden to bring with or show inappropriately content in any form within the area of Stari grad- Old town.

#### **Article 19**

It is forbidden to take any historical or cultural artefacts within the area of Old town- Stari grad with you, unless previously agreed upon with the Center.

#### **Article 20**

Entry is forbidden for person that are intoxicated in any way.

#### **Article 21**

Entry is forbidden for employees of the Center, visitors and other citizens unless properly dressed.

#### **Article 22**

- (1) It is allowed to organise events (concerts, conventions, exhibitions etc.) under the terms of Rulebook for usage and renting of Stari grad-Old town.
- (2) Organisers are obligated to provide any necessary safety, technical and legal terms for these events.

#### **Article 23**

All visitors, employees of the Center and other citizens are invited to read house regulation rulebook during their stay at Old town- Stari grad.

#### **Article 24**

Employees of the Center are obligated to implement the articles of the house regulation rulebook.

**Article 25**

In case of disorderly behaviour employees of the Center are obligated to, within their jurisdiction, take appropriate measures and it necessary to ask visitors, who do not respect house regulation rulebook, to leave the area of Old town- Stari grad.

**Article 26**

Employees of the Center, visitors of Old town- Stari grad and other citizens who intentionally cause material damage of any kind to the properties of Stari grad- Old town are obligated to pay for the damage they caused.

**Article 27**

The amount of fine will be assessed by a competent individual hired by the director of Center.

**Article 28**

This rulebook will be posted inside the area of Old town- Stari grad, and it shall take effect on the date of its adoption.
